# **Privacy Policy**

This Privacy Policy governs the privacy policies and practices of Sherri the Outdoor Adventurer ("lâ€, "meâ€, or "myâ€) which operates the https://sherritheoutdooradventurer.com/website (hereinafter referred to as the "Websiteâ€).

This page informs you of our policies regarding the collection, use and disclosure of personal data when you use my Website and the choices you have associated with that data.

### **Information Collection and Use**

I collect several different types of information for various purposes to provide and improve my Website for you.

### Types of Data Collected

Personal Data

While using my Website, I may ask you to provide me with certain personally identifiable information that can be used to contact or identify you ("Personal Dataâ€). Personally identifiable information may include, but is not limited to:

- Email address
- First name and last name
- Phone number
- Cookies and Usage Data

I may use your Personal Data to contact you with newsletters, marketing or promotional materials and other information that may be of interest to you. You may opt out of receiving any, or all, of these communications from me by following the unsubscribe link in any email I send.

Usage Data

I may also collect information on how the Website is accessed and used ("Usage Dataâ€). This Usage Data may include information such as your computer's browser type, browser version, the pages of my Website that you visit, the time and date of your visit, the time spent on those pages, unique device identifiers and other diagnostic data.

Tracking & Cookies Data

I use cookies and similar tracking technologies to track the activity on my Website and I hold certain information.

Cookies are files with a small amount of data which may include an anonymous unique identifier. Cookies are sent to your browser from a website and stored on your device. Other tracking technologies are also used such as beacons, tags and scripts to collect and track information and to improve and analyze my Website.

You can instruct your browser to refuse all cookies or to indicate when a cookie is being sent. However, if you do not accept cookies, you may not be able to use some portions of my Website.

#### Examples of Cookies I use:

- Session Cookies. I use Session Cookies to operate our Website.
- **Preference Cookies.** use Preference Cookies to remember your preferences and various settings.
- Security Cookies. I use Security Cookies for security purposes.
- Advertising Cookies. Advertising Cookies are used to serve you with advertisements that may be relevant to you and your interests.

#### **Use of Data**

- To provide and maintain my Website
- To allow you to participate in interactive features of my Website when you choose to do so
- To provide customer support
- To gather analysis or valuable information so that I can improve my Website

# Legal Basis for Processing Personal Data under the General Data Protection Regulation (GDPR)

If you are from the European Economic Area (EEA), Sherri the Outdoor Adventurer's legal basis for collecting and using the personal information described in this Privacy Policy depends on the Personal Data I collect and the specific context in which I collect it.

Sherri the Outdoor Adventurer may process your Personal Data because:

- I need to perform a contract with you
- You have given me permission to do so
- The processing is in my legitimate interests and it is not overridden by your rights

To comply with the law

#### Retention of Data

Sherri the Outdoor Adventurer will retain your Personal Data only for as long as is necessary for the purposes set out in this Privacy Policy. I will retain and use your Personal Data to the extent necessary to comply with my legal obligations (for example, if I am required to retain your data to comply with applicable laws), resolve disputes and enforce my legal agreements and policies.

Sherri the Outdoor Adventurer will also retain Usage Data for internal analysis purposes. Usage Data is generally retained for a shorter period of time, except when this data is used to strengthen the security or to improve the functionality of my Website, or I am legally obligated to retain this data for longer periods.

## **Disclosure of Data**

Legal Requirements

Sherri the Outdoor Adventurer may disclose your Personal Data in the good faith belief that such action is necessary to:

- To comply with a legal obligation
- To protect and defend the rights or property of Sherri the Outdoor Adventurer
- To prevent or investigate possible wrongdoing in connection with the Website
- To protect the personal safety of users of the Website or the public
- To protect against legal liability

# **Security of Data**

# Your Data Protection Rights under the General Data Protection Regulation (GDPR)

You can opt-out of having made your activity on the Website available to Google Analytics by installing the Google Analytics opt-out browser add-on.
